### Play-Based Learning by Sue Yearick, Director


At Park Forest Preschool, we emphasize play-based learning. This educational approach is child initiated and teacher supported. Our classrooms are set up to offer a variety of enticing hands-on activities from which children choose. Teachers interact with the children, commenting on what they are doing, and asking children questions such as:

- Tell me about your building.
- What do you think you will do next?
- I noticed that you took a deep breath when your tower fell down and then you started building again.

Play-based learning has many benefits for children's development, such as:

- Promotes language development;
- Fosters creativity and imagination;
- Creates a positive relationship with learning;
- Develops social-emotional skills; and
- Improves motor skills.

The following graphic, from Rooted in Play, illustrates that while an observer sees children playing, much learning is going on below the surface.

## Park Forest Preschool Now Participates in the **EITC** (an educational tax credit program)

Pennsylvania's Educational Improvement Tax Credit (EITC) offers individuals and businesses an opportunity to invest a portion of their tax dollars into education programs that directly benefit students.

The State Department of Community and Economic Development's Tax Credit Division oversees the EITC program. There is no fee to participate in the program.

The minimum EITC gift in any calendar year is \$3,500. You can make a gift up to the amount of your state taxes. The funds Park Forest Preschool receives under the EITC program directly support tuition scholarships for low-income students, ages three and four. The EITC program allows you to get a 90% tax credit against your PA tax liability.
